I am requesting funding for Restoration of William Cook Auditorium at Anaheim High School project in fiscal year 2023. The entity to receive funding for this project is the Anaheim Union High School District, located at 501 N Crescent Way, Anaheim, CA 92801. The project will be located at 811 W Lincoln Ave, Anaheim, CA 92805.

Cook Auditorium is in desperate need of modernization and restoration, as its construction was prior to known health hazards associated with asbestos and recent damage to the ceiling has resulted in exposed rafters and the closure of the facility. Given the age of the building and hazards associated with disposing of asbestos, the AUHSD facilities division is requesting \$2,000,000 for the initial planning phase of this project to better determine the scope of work required to restore the auditorium prior to pursuing a bond or other funds.
